Discussion: I explained to Mr. Stevens that the small cesium sources that are in the detectors crystals appeared to be distributed as generally licensed devices. In order to distribute them inside the well logging tool, he would need to convert them to specifically licensed and add them to his specific license. After a discussion, he stated that he would like to be licensed for up to 1 millicuries for these sources. I also discussed that he would need to notify into NRC headquarters to convert the sources from generally licensed to specifically licensed.
