Dear Mr. Hamilton:

On December 13, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a Cyber Security Inspection at your Perry Nuclear Power Plant, Unit 1. The enclosed inspection report documents the inspection results, which were discussed on December 13, 2016, with Mr. Hamilton and other members of your staff.

The NRC inspector documented one finding of very low safety significance (Green) in this report. This finding involved a violation of NRC requirements. The finding did have a cross-cutting aspect in the area of Human Performance, consistent process because the licensee failed to utilize a consistent, systematic approach to make decisions. However, because of its very low safety significance, and because the issue was entered into your Corrective Action Program, the NRC is treating the issue as a Non-Cited Violation in accordance with Section 2.3.2 of the NRC Enforcement Policy. If you contest the subject or severity of the Non-Cited-Violation, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001, with copies to the Regional Administrator, Region III; the Director, Office of Enforcement, U.S. Nuclear Regulatory Commission, Washington, DC 20555-0001; and the NRC Resident Inspector at the Perry Nuclear Power Plant.

In accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390, "Public Inspections, Exemptions, Requests for Withholding," of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC's Public Document Room or from the Publicly Available Records (PARS) component of the NRC's Agencywide Documents Access and Management System (ADAMS).
