This letter refers to an inspection conducted from October 1 through December 31, 2016, at the BWXT Nuclear Operations Group, Inc., facility in Lynchburg, VA. The purpose of this inspection was to determine whether activities authorized under the license were conducted safely and in accordance with U.S. Nuclear Regulatory Commission (NRC) requirements. At the conclusion of the inspection, the results were discussed on January 12, 2017, with you and members of your staff. The enclosed inspection report documents the results of the inspection.

The inspection consisted of an examination of activities conducted under the license as they relate to the common defense, security, compliance with the Commission's rules and regulations, and with the conditions of the license. Areas examined during the inspection are identified in the enclosed report. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations of activities in progress, and interviews with personnel.

There were no violations of NRC requirements identified during the inspection.
