In conformance with the FOIA Improvement Act of 2016, the NRC is informing you that you have the right to seek assistance from the NRC's FOIA Public Liaison.

There are a few facilities specifically licensed for Low Level Waste (LLW) storage by agreement states- e.g. WCS in Texas, Energy Solutions in SC and TN. NRC regulations do not require licensees to differentiate between radioactive material and LLW, there are likely dozens to hundreds of ad hoc LLW "storage" facilities at any given time.

Of those sites, only two are not spent fuel, which are Private Fuel Storage and the DOE Idaho Spent Fuel Storage Facility, both of which are specific licensed ISFSIs.

The FOIA Improvement Act of 2016, which was enacted on June 30, 2016, made several changes to the Freedom of Information Act (FOIA).
