SUBJECT: NOTIFICATION CONCERNING YOUR EXPIRED LICENSE

Dear Mr. Gleason:

This letter is to inform you that your U.S. Nuclear Regulatory Commission (NRC) Exempt Distribution Materials License No. 20-32465-02E expires on January 31, 2017.

Please note that Title 10 of the *Code of Federal Regulations* (10 CFR) 30.36(a) states: "Each specific license expires at the end of the day on the expiration date stated in the license, unless the licensee has filed an application for renewal under § 30.37 not less than 30 days before the expiration date stated in the existing license." As discussed with you and your consultant Mr. Sean Chapel over the phone and by e-mail on January 4, 2017, we cannot grant any more additional time due to the timely renewal requirement for this license. Additionally, we have reiterated that the renewal application needs to include all documentation that is required under 10 CFR 32.18, 32.26 and 30.32. Although we received your renewal application on January 12, 2017 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML17030A071, non-public), the application only contains the NRC Form 313 and a copy of your NRC distribution license without any required information. Therefore, after January 31, 2017, products can no longer be distributed under the expired Exempt Distribution Materials License No. 20-32465-02E.

In accordance with 10 CFR 2.390 of NRC's "Agency Rules of Practice and Procedure," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC's Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
