
Affidavit for Withholding SCE&G's Information

Affidavit of April Rice

1. My name is April Rice. I am the Manager, New Nuclear Licensing, for South Carolina Electric & Gas Company (SCE&G). I have been delegated the function of reviewing proprietary information sought to be withheld from public disclosure and am authorized to apply for its withholding on behalf of SCE&G.
2. I am making this affidavit on personal knowledge, in conformance with the provisions of 10 CFR Section 2.390 of the Commission's regulations and in conjunction with SCE&G's filings on dockets 52-027 and 52-028, Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3. I have personal knowledge of the criteria and procedures used by SCE&G to designate information as a trade secret, privileged or as confidential, commercial or financial information.
3. In accordance with 10 C.F.R. §2.390, I am making this Affidavit to support SCE&G's request for withholding, contained in the letter accompanying this Affidavit. The specific information to be withheld is contained in Enclosure 3, Proprietary Version of VCSNS Units 2 and 3 Response to Request for Additional Information #1 – LTR-PAFM-16-59-P, NRC RAI Response Regarding Inspection of AP1000 Vogtle Units 3 & 4 and V.C. Summer Units 2 & 3 Steam Generator to Reactor Coolant Pump Suction Nozzle Weld Rev 1.
4. The information is sought to be withheld under 10 C.F.R. §2.390(a)(4), as it is confidential commercial information. In support of this request for withholding and pursuant to 10 C.F.R. §2.390(b)(4), I state the following:
 - i. The information sought to be withheld from public disclosure has been held in confidence by SCE&G and Westinghouse Electric Company.
 - ii. The information is of a type customarily held in confidence by SCE&G and Westinghouse Electric Company and not customarily disclosed to the public.
 - iii. This information is being transmitted to the NRC in confidence.
 - iv. The release of the information might result in the loss of an existing or potential competitive advantage to SCE&G and/or Westinghouse Electric Company.
 - v. This information is not available in public sources.
 - vi. Other reasons identified in Enclosure 5 of SCE&G letter NND-17-0035 for VCSNS Units 2 and 3, Westinghouse Application for Withholding Proprietary Information from Public Disclosure CAW-16-4509, accompanying Affidavit, Proprietary Information Notice, and Copyright Notice, and those reasons are incorporated here by reference.
 - vii. Release of the information may harm SCE&G because SCE&G has a contractual relationship with the Westinghouse Electric Company regarding proprietary information. SCE&G is contractually obligated to seek confidential and proprietary treatment of the information.



- (1) I am Manager, Regulatory Compliance, Westinghouse Electric Company LLC ("Westinghouse"), and as such, I have been specifically delegated the function of reviewing the proprietary information sought to be withheld from public disclosure in connection with nuclear power plant licensing and rule making proceedings, and am authorized to apply for its withholding on behalf of Westinghouse.
- (2) I am making this Affidavit in conformance with the provisions of 10 CFR Section 2.390 of the Commission's regulations and in conjunction with the Westinghouse Application for Withholding Proprietary Information from Public Disclosure accompanying this Affidavit.
- (3) I have personal knowledge of the criteria and procedures utilized by Westinghouse in designating information as a trade secret, privileged or as confidential commercial or financial information.
- (4) Pursuant to the provisions of paragraph (b)(4) of Section 2.390 of the Commission's regulations, the following is furnished for consideration by the Commission in determining whether the information sought to be withheld from public disclosure should be withheld.
 - (i) The information sought to be withheld from public disclosure is owned and has been held in confidence by Westinghouse.
 - (ii) The information is of a type customarily held in confidence by Westinghouse and not customarily disclosed to the public. Westinghouse has a rational basis for determining the types of information customarily held in confidence by it and, in that connection, utilizes a system to determine when and whether to hold certain types of information in confidence. The application of that system and the substance of that system constitute Westinghouse policy and provide the rational basis required.

Under that system, information is held in confidence if it falls in one or more of several types, the release of which might result in the loss of an existing or potential competitive advantage, as follows:

- (a) The information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of

Westinghouse's competitors without license from Westinghouse constitutes a competitive economic advantage over other companies.

- (b) It consists of supporting data, including test data, relative to a process (or component, structure, tool, method, etc.), the application of which data secures a competitive economic advantage, e.g., by optimization or improved marketability.
 - (c) Its use by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.
 - (d) It reveals cost or price information, production capacities, budget levels, or commercial strategies of Westinghouse, its customers or suppliers.
 - (e) It reveals aspects of past, present, or future Westinghouse or customer funded development plans and programs of potential commercial value to Westinghouse.
 - (f) It contains patentable ideas, for which patent protection may be desirable.
- (iii) There are sound policy reasons behind the Westinghouse system which include the following:
- (a) The use of such information by Westinghouse gives Westinghouse a competitive advantage over its competitors. It is, therefore, withheld from disclosure to protect the Westinghouse competitive position.
 - (b) It is information that is marketable in many ways. The extent to which such information is available to competitors diminishes the Westinghouse ability to sell products and services involving the use of the information.
 - (c) Use by our competitor would put Westinghouse at a competitive disadvantage by reducing his expenditure of resources at our expense.

- (d) Each component of proprietary information pertinent to a particular competitive advantage is potentially as valuable as the total competitive advantage. If competitors acquire components of proprietary information, any one component may be the key to the entire puzzle, thereby depriving Westinghouse of a competitive advantage.
 - (e) Unrestricted disclosure would jeopardize the position of prominence of Westinghouse in the world market, and thereby give a market advantage to the competition of those countries.
 - (f) The Westinghouse capacity to invest corporate assets in research and development depends upon the success in obtaining and maintaining a competitive advantage.
- (iv) The information is being transmitted to the Commission in confidence and, under the provisions of 10 CFR Section 2.390, it is to be received in confidence by the Commission.
- (v) The information sought to be protected is not available in public sources or available information has not been previously employed in the same original manner or method to the best of our knowledge and belief.
- (vi) The proprietary information sought to be withheld in this submittal is that which is appropriately marked in LTR-PAFM-16-59-P, Revision 1, "NRC RAI Response Regarding Inspection of AP1000 Vogtle Units 3 & 4 and V.C. Summer Units 2 & 3 Steam Generator to Reactor Coolant Pump Suction Nozzle Weld" (Proprietary), for submittal to the Commission, being transmitted by Southern Nuclear Operating Company and South Carolina Electric & Gas Company letter and Application for Withholding Proprietary Information from Public Disclosure, to the Document Control Desk. The proprietary information as submitted by Westinghouse is that associated with technical justification to support inspection coverage for AP1000® plant steam generator to reactor coolant pump dissimilar metal weld at Vogtle Units 3 and 4 and V.C. Summer Units 2 and 3, and may be used only for that purpose.

- (a) This information is part of that which will enable Westinghouse to:
 - (i) Provide technical justification to support inspection coverage for *API1000* plant steam generator to reactor coolant pump dissimilar metal weld at Vogtle Units 3 and 4 and V.C. Summer Units 2 and 3.
- (b) Further this information has substantial commercial value as follows:
 - (i) Westinghouse plans to sell the use of similar information to its customers for the purpose of providing technical justification to support extended volumetric examination interval for reactor vessel nozzle to safe end dissimilar metal welds.
 - (ii) Westinghouse can sell support and defense of industry guidelines and acceptance criteria for plant-specific applications.
 - (iii) The information requested to be withheld reveals the distinguishing aspects of a methodology which was developed by Westinghouse.

Public disclosure of this proprietary information is likely to cause substantial harm to the competitive position of Westinghouse because it would enhance the ability of competitors to provide similar technical evaluation justifications and licensing defense services for commercial power reactors without commensurate expenses. Also, public disclosure of the information would enable others to use the information to meet NRC requirements for licensing documentation without purchasing the right to use the information.

The development of the technology described in part by the information is the result of applying the results of many years of experience in an intensive Westinghouse effort and the expenditure of a considerable sum of money.

In order for competitors of Westinghouse to duplicate this information, similar technical programs would have to be performed and a significant manpower effort, having the requisite talent and experience, would have to be expended.
