PURPOSE: To continue the mediation session that took place on December 12, 2016, as part of the U.S. Nuclear Regulatory Commission (NRC)'s Alternative Dispute Resolution (ADR) program related to the following five apparent violations of NRC regulations: (1) implementation of the Reinjection Program in a manner inconsistent with the ground water Corrective Action Program (CAP); (2) discharge of liquid effluents from the Reverse Osmosis (RO) plant in excess of the site ground water protection standards established in the license; (3) failure to report to the NRC the results of all effluent monitoring required by the license; (4) failure to obtain monthly composite samples as required by the license; and (5) the discharge of liquid effluents containing byproduct material to land application areas without first obtaining NRC approval. The issues are described in the NRC's letter dated October 4, 2016, Agencywide Documents Access and Management System (ADAMS) Accession No. ML16251A526.
