Andrea,

The following is Perma-Fix's response to the comments made by the Northwest Interstate Compact. Please let me know if you need a formal response on Perma-Fix letterhead. Thanks.

1. Any resulting secondary waste, clearly identifiable to the Canadian generator, and any shipping containers that are not recycled/reused, are not eligible for disposal at the Clive, UT or Richland, W A commercial disposal facilities, and shall be shipped back to the Canadian generator. **Perma-Fix response: We concur.**
2. In the import and export application, Block 15 and Block 10 respectively, it is not clear what "Waste returned to Canada under this export license can exceed Table A2 values of 49 CFR 173.435 if the radioactivity is within the State of Washington issued Radioactive Materials license and meets all Department of Transportation requirements for transporting the waste" means. Does this mean the processed waste can be packaged in a Type B container when it is shipped back to the Canadian generator? **Perma-fix response: Perma-Fix will follow DOT rules and regulations while shipping Radioactive material to and from the Richland, Washington facility. The Radioactive materials license at the Washington facility will be adhered to for receiving, processing and storing of the radioactive material once it arrives. The License issued by Washington State is independent of the DOT regulations and regulates the waste once it arrives at the facility. Although the waste/material may exceed the A2 values mentioned as part of the DOT regulations it will most certainly be shipped in accordance with the applicable DOT rules and regulations.**
