Mr. McCree,

On Dec. 9, 2015 under both the Freedom of Information Act and the Privacy Act I requested all records pertaining to me contained in the NRC's Privacy Act System of Records NRC-23, Office of Investigations Indices, Files, and Associated Records--NRC.

On Dec. 10, 2015 the NRC assigned my request the tracking number FOIA/PA 2016-0137 and estimated the records would be received by January 8, 2016.

On January 6, 2016 an NRC FOIA contractor informed me my records would not be received until January 22, 2017--267 working days after the receipt of the FOIA/PA request by the agency.

Under the Freedom of Information Act, you had 30 working days to provide me the requested records; it has thus far been 60 working days.

10 CFR 9.65(a) states, in part:

The Freedom of Information Act and Privacy Act Officer shall notify the requesting individual in person or in writing of the determination. Unless the request presents unusual difficulties or involves extensive numbers of records, individuals shall be notified of determinations to grant or deny access within 30 working days after receipt of the request.

I believe that taking 267 working days to answer my Privacy Act request is excessive and is an abuse of 10 CFR 9.65.

Under the Freedom of Information Act and 10 CFR 9.35(j) I am appealing the Lack of Response to FOIA/PA request 2016-0137.

FOIA case law recognizes that there are times when the volume of records requested might exceed the ability of the agency to process the request within the time limits specified by the FOIA. Under such circumstances, case law demands that the agency make regular responses to the requester as records become available. I do not believe the volume of records requested by me under FOIA/PA 2016-0137 is so excessive that my request could not be answered within 30 working days. It has been 60 working days and I have yet to receive a single record. This indicates to me that no effort whatsoever has been put into answering my response. If records have been located and processed, you should provide them to me immediately as a partial response.

On January 17, 2016, I requested, under the provisions of FOIA, a copy of the results and conclusions of an investigation conducted by Special Agent Tim Pikas, of the Inspector General's Office. My request was acknowledged by a letter dated January 17th, addressed to (b)(6) and assigned a tracking number of FOIA/PA-2016-00253. On February 23rd, the NRC responded with a report that was heavily redacted, supposedly to protect certain individuals' privacy. All the principals' names were removed. Even the pronouns were removed.

Note that, since I'm the complainant in this IG report, I know almost all the people whose names were redacted. I can fill in the blanks myself. So, I don't understand how these individuals' privacy was protected. I also don't understand why the NRC needed two forms of ID, from me, in order to produce this gutted report. I must conclude that this redaction process was largely a waste of the NRC staff's time, resources, and taxpayers' dollars, in general.

I am not at all satisfied with the NRC's response to my FOIA request, since I have no way of knowing that the report I requested is the report I received. I regret that I must appeal this FOIA response. Please resend the report without redaction.

This is a request filed under the Freedom of Information Act, as amended. Per the applicable law and Nuclear Regulatory Commission regulations, I anticipate a response to this request within 20 days.

This request is being filed on behalf of Savannah River Site Watch (SRS Watch), a corporation duly registered with the State of South Carolina and a duly registered 501c(3) non-profit organization. While now working for SRS Watch, I have filed many FOIA requests, including with the NRC, on behalf of other non-profit organizations, including Friends of the Earth, the Alliance for Nuclear Accountability, Greenpeace and the Nuclear Control Institute.

I request that any fees that may be associated with this request be waived. The information obtained due to this request will be used solely for non-profit purposes in Georgia, South Carolina and in the United States. The information will contribute to the public's understanding of the manner in which NRC conducts its business and will specifically be used to inform the public about the NRC's regulation of new nuclear reactor construction and its efforts to investigate possible waste, fraud, abuse and mismanagement associated with such projects.

The information obtained via this request will be provided to not only the public but also the media and regulatory authorities in the states of Georgia and South Carolina. Over the years, I have demonstrated an ability to use information gathered via FOIA requests in a manner so as to educate the public about NRC and issues under its oversight. I request that the fee-waiver standard that has been applied to my requests in the past be applied to this request.

If any claim is made that any portion of any located documents are sensitive in nature or meet FOIA exclusions, I request that redacted copies of such documents be provided to me and that a full explanation be provided as to the reasons for any redactions.



I request that the documents and individual files on the requested allegations be provided to me as they become available and not be withheld until all pertinent documents are obtained.

Judicial Watch, Inc. ("Judicial Watch") hereby requests that the Nuclear Regulatory Commission ("NRC") produce the following records pursuant to the Freedom of Information Act, 5 U.S.C. § 552 ("FOIA"):

1. Any and all documentation of NRC adjustments and/or concessions from the year 2010 to the present made to Southern Co./Georgia Power regarding licensing and quality control requirements for two nuclear plant construction projects, plant Vogtle in Georgia and VC Summer in North Carolina.

2. Any and all documentation including audio and video, including but not limited to that involving (b)(6) and (b)(6) (b)(6) referencing investigations that were initiated and/or completed between June 2015 and May 2016 focusing on complaints/concerns about the buying and selling of weapons, as well as intimidation of Chicago Bridge & Iron ("CB&I") inspectors.

Please determine whether to comply with this request within the time period required by FOIA and notify us immediately of your determination, the reasons therefor, and the right to appeal any adverse determination to the head of the agency or his or her designee. 5 U.S.C. § 552(a)(6)(i). Please also produce all responsive records in an electronic format ("pdf" is preferred), if convenient. We also are willing to accept a "rolling production" of responsive records if it will facilitate a more timely production.

Judicial Watch also hereby requests a waiver of both search and duplication fees. We are entitled to a waiver of search fees because we are a "representative of the news media." See 5 U.S.C. § 552(a)(4)(A)(ii)(II); see also *Cause of Action v. Federal Trade Comm.*, 799 F.3d 1108 (D.C. Cir. 2015); *Nat'l Sec. Archive v. U.S. Dep't of Defense*, 880 F.2d 1381 (D.C. Cir. 1989). For more than twenty years, Judicial Watch has used FOIA

and other investigative tools to gather information about the operations and activities of government, a subject of undisputed public interest. We submit over 400 FOIA requests annually. Our personnel, which includes experienced journalists and professional writers on staff and under contract, use their editorial skills to turn this raw information into distinct works that are disseminated to the public via our monthly newsletter, which has a circulation of over 300,000, weekly email update, which has over 600,000 subscribers, investigative bulletins, special reports, www.judicialwatch.org website, *Corruption Chronicles* blog, and social media, including Facebook and Twitter, among other distribution channels. We have authored several books, including *Corruption Chronicles* by Tom Fitton (Threshold Editions, July 24, 2012), and another book, *Clean House* by Tom Fitton (Threshold Editions, Aug. 30, 2016), is forthcoming. In 2012, we produced a documentary film, "District of Corruption," directed by Stephen K. Bannon. Our "news media" status has been confirmed in court rulings. See, e.g., *Judicial Watch, Inc. v. U.S. Dep't of Defense*, 2006 U.S. Dist. LEXIS 44003, *1 (D.D.C. June 28, 2006); *Judicial Watch, Inc. v. U.S. Dep't of Justice*, 133 F. Supp.2d 52 (D.D.C. 2000). As a tax exempt, 501(c)(3) non-profit corporation, we have no commercial interests and do not seek the requested records for any commercial use. Rather, we intend to use the requested records as part of our on-going investigative journalism and public education efforts to promote integrity, transparency, and accountability in government and fidelity to the rule of law.

Judicial Watch also is entitled to a waiver of both search fees and duplication fees because "disclosure of the information is in the public interest." 5 U.S.C. § 552(a)(4)(A)(iii). Disclosure of the requested records undoubtedly will shed light on "the operations or activities of the government." *Cause of Action*, 799 F.3d at 1115 (quoting 5 U.S.C. § 552(a)(4)(A)(iii)). Disclosure also is "likely to contribute significantly to the public understanding" of those operations or activities because, among other reasons, Judicial Watch intends to disseminate both the records and its findings to "a reasonably broad audience of persons interested in the subject" via its newsletter, email updates, investigative bulletins, website, blog, and its other, regular distribution channels. *Cause of Action*, 799 F.3d at 1116 (quoting *Carney v. U.S. Dep't of Justice*, 19 F.3d 807, 815 (2d Cir. 1994)). Again, Judicial Watch does not seek the requested records for any commercial benefit or for its own "primary" benefit, but instead seeks them as part of its ongoing investigative journalism and public education efforts to promote integrity, transparency, and accountability in government and fidelity to the rule of law.

In the event our request for a waiver of search and/or duplication costs is denied, Judicial Watch agrees to pay up to \$300.00 in search and/or duplication costs. Judicial Watch requests that it be contacted before any such costs are incurred, in order to prioritize search and duplication efforts.

Re: Freedom of Information Act Request

Dear FOIA officer:

I am making this request under the Freedom Of Information Act ("FOIA"), 5 U.S.C. 552. Please provide records that are maintained by the U.S. Nuclear Regulatory Commission or for the agency by a government contractor in any format, including an electronic format. Please provide:

1. Any and all correspondence, memoranda, e-mails, reports, facsimiles, etc., regarding tornado emergency protocols at licensed nuclear power facilities.
2. Any and all correspondence, memoranda, e-mails, reports, facsimiles, etc., regarding the wind speeds and tornado conditions licensed nuclear power facilities are required to withstand.

I request a waiver of all costs associated with fulfilling this submission pursuant to 5 U.S.C. 552(a)(4)(A)(iii). Disclosure of the requested records will contribute significantly to public's understanding of the operations or activities of the government and would not be primarily in the commercial interest of POGO. Specifically, POGO intends to use the requested records to highlight for the public the potential of a nuclear incident in which a category 4 or 5 tornado directly hits a nuclear reactor.

I have included this FOIA Fee Waiver Supplement to provide a detailed account of POGO's planned use of the requested information and to fully respond to NRC's fee waiver criteria.

1. The subject of the request: Whether the subject of the requested records concerns "the operations or activities of the government."

The NRC regulates 61 commercial power plants in the U.S. totaling 99 nuclear reactors. Some of these plants are in areas that are prone to frequent, strong tornados including many plants in Texas, Kansas, Missouri, Indiana, Arkansas, and Iowa. The meltdown at the Fukushima Daiichi plant in Japan in 2011 forced the evacuation of hundreds of square miles and highlighted the potential danger of natural disasters striking nuclear power facilities. POGO has long been committed to ensuring the safety and security of commercial and defense nuclear facilities. POGO is also focused on increasing the public understanding of the operations or activities of the government with regards to effective management at nuclear facilities.

2. The informative value of the information to be disclosed: Whether the disclosure is "likely to contribute" to an understanding of government operations or activities.

POGO provides a valuable public service by taking an independent look at how the government spends taxpayer dollars and what can be done to make the system more effective, efficient, accountable, and honest. POGO will likely release a publication analyzing the efficacy of the NRC's tornado safety standards. The publication will build on POGO's previous publications that seek to inform the public about management at major domestic and military nuclear facilities. All POGO publications include government reports, documents, and other resources to allow the public to better understand how the federal government operates.

POGO has established a niche in informing the general public, either through its own publications and web site or through media outlets, about the issue of nuclear facilities management. POGO has issued reports and offered public comments on this issue, frequently urging Congress and various agencies to embrace efficient nuclear infrastructure management.

3. The contribution to an understanding by the general public of the subject likely to result from the disclosure, taking into account your ability and intent to disseminate the information to the public in a form that can further understanding of the subject matter.

POGO investigates, exposes, and seeks to remedy systemic abuses of power, mismanagement, and subservience by the federal government to powerful special interests. Founded in 1981, POGO is a politically independent, nonprofit watchdog that promotes a government that is accountable to the citizenry. POGO disseminates information about its activities to thousands of concerned citizens, policymakers, and the media via email, direct mail, and its web site <http://www.pogo.org>, the organization's primary vehicle for disseminating information to concerned citizens and other targeted constituencies. The site receives approximately one million hits and 100,000 unique visitors monthly. In addition, the "POGO Blog" has developed its own readership, averaging roughly 20,000 visitors monthly, allowing us to reach new readers in the blogosphere. The documents provided will be used for the following activities: publication by email, on our website, in reports, and newsletters issued by POGO and disseminated to POGO supporters, the public, the media, nonprofit organizations, Congress, Executive Branch officials, and other policymakers.

4. The significance of the contribution to public understanding: Whether the disclosure is likely to contribute "significantly" to public understanding of government operations or activities.

POGO concludes that these documents will be of interest to the general public. Our hope is that the report will allow us to inform the public about U.S. nuclear power plants, the

performance of those sites, their efforts to prepare for natural disasters, and plans to make such facilities safer, more efficient, and effective.

5. Describe any commercial or private interest the requester or any other party has in the agency records sought.

POGO does not charge for access to its web site, reports, newsletters, or other publications. Additionally, POGO does not have a financial or commercial interest in the report sought by the attached FOIA request.

If this request is denied in full or in part, please cite each exemptions pursuant to 5 U.S.C. ' 552(b) that justifies each denial. If an exemption applies, however, please consider exercising the agency's discretionary release powers to disclose the records. Any such action supports the presumption of "openness" on which FOIA is based upon. Additionally, please release all reasonably segregable portions of the records that do not meet an exemption. 5 U.S.C. ' 552(b).

I look forward to your response, including an individualized tracking number, within 20 days of the receipt of this request, unless, in the case of "unusual circumstances," the time limitation is "extended by written notice." 5 U.S.C. ' 552(a)(6)(B). I am aware that all fees will be waived if specified time limits are not met. 5 U.S.C. ' 552(a)(4)(A)(viii). I have a right to appeal if this request is wholly or partially denied or if the agency fails to respond within 20 days, and that, if successful, a federal district court may assess "reasonable attorney fees and other litigation costs." 5 U.S.C. ' 552(a)(4)(E).

Please contact me if this request requires further clarification. Thank you for your prompt attention to this matter.

Waiver_Purpose: UCS was surprised to read in OIG Audit Report OIG-15-A-18 (ML15230A563) that OIG found no evidence that political appointees had improperly interfered in the NRC's FOIA process. The handling of our own FOIA request (FOIA/PA-2013-00008) strongly suggests otherwise. UCS seeks the requested records because they relate to the records and issues initially requested by FOIA/PA-2013-00008. It took the NRC over 11 months to provide the 19-page letter requested in FOIA/PA-2013-00008. UCS seeks the requested records to more fully understand why the response was so protracted and who was involved in the delay.

Waiver_ExtentToExtractAnalyze: UCS will review the requested records in hopes of filling in the timeline of who knew what when regarding the Jocassee Dam issues. Senator Lieberman referred to OIG an inquiry he'd received. OIG may have opened an investigation or inquiry in response to the Senator's letter. If so, OIG's records likely contain information that will supplement our understanding from other records extracted from the NRC via FOIAs about the agency's efforts to address safety issues affecting Oconee.

Waiver_SpecificActivityQuals: UCS has been actively engaged on two aspects of this matter: (1) the technical aspect involving the flooding hazard at Oconee from the Jocassee Dam, and (2) the access to information aspect involving the NRC's withholding of its June 2010 Confirmatory Action Letter to Duke and its delay in providing a 19-page letter in response to our FOIA/PA-2013-00008. The records we request in this FOIA will likely speak most to this second aspect. Our prior extension engagement in the Oconee flood protection and information access issues will enable UCS to review the requested records to better understand the fuller context, which will enhance our ability to communicate that context to various audiences: Congress, the NRC, the media, and the public.

Waiver_ImpactPublicUnderstanding: Audit OIG-15-A-18 was conducted in response to a request from the U.S. Congress. The NRC is a federal agency tasked with protecting the public. The Senate's request is illustrative of the public's interest in and concern whether federal agencies like the NRC are properly providing public access to information. To UCS, the OIG audit report seems to provide a distorted picture of the situation. UCS seeks the requested records to better understand how the OIG audit reached its conclusions. Whether the requested records show foundation or not, UCS will communicate our assessment to various audiences: Congress, the NRC, the media, and the public. Our efforts will reach wider audiences than the OIG audit report reached.

Waiver_NatureOfPublic: UCS posted materials to our website, www.ucsusa.org, and blog, allthingsnuclear.org. Our materials about Oconee's flood protection issues and about NRC's information access issues have been among the most viewed of our nuclear safety postings over the past three years (topped by Fukushima, but not by too many other topics). UCS expects above average interest in our commentary about this subject.

Waiver_MeansOfDissemination: UCS prepares fact sheets, blog commentaries, presentations, reports, and issue briefs that are submitted to Congress and the NRC or posted to our website or blog. UCS expects to use one or more of these communication tools to convey the results from our review and assessment of the requested records.

Pursuant to the Freedom of Information Act, 5 U.S.C. 522, as amended and 10 C.F.R. 9.8 of the Commission's regulations Greenpeace requests that the Nuclear Regulatory Commission provide us with any and all documents associate with the Summer Special Inspection that was initiated on February 23, 2015.

Please consider "documents" to include reports, studies, test results, correspondence memoranda, meeting notes, meeting minutes, working papers, graphs, charts, diagrams, notes from drop-in visits and summaries of conversations and interviews, computer records, e-mail and any other form of written communications including internal NRC memoranda.

Pursuant to and in compliance with 10 C.F.R. 9.41 of the Commission's regulations governing requests for fee waivers, Greenpeace provides the following information.

Greenpeace seeks the requested information solely to contribute to and help shape the public debate concerning NRC's role in the regulation of the nuclear industry. The information provided by the NRC will be analyzed and used in our on-going work with public interest groups and the media tracking NRC's ITAAC process for new construction and the supposed nuclear "renaissance."

Greenpeace is a nationally known non-profit public interest organization founded in 1971. We will use these documents in preparation of our analysis of the delays and cost overruns which still plague the nuclear industry's new construction projects in Georgia, South Carolina and Tennessee.

The requested information and Greenpeace's analysis will greatly contribute to the public's understanding of the Commission's role in regulating the nuclear industry. Some three months after the Special Inspection was instigated not even the Special Inspection Team Charter has found its way into NRC ADAMS. The Special Inspection is well past the 45 day deadline which NRC mentioned in its press release (above) and there is yet no explanation in the public domain as to why this is the case. I have been told by NRC staff that the scope of the Special Inspection has been broadened but there is nothing available from NRC that would indicate that is the case.

We plan to broadly disseminate the information contained in our analysis to the press and the general public. For several years now our publications, comments and press releases have been made available free of charge on our web site. The requested information will significantly increase the public understanding of the issue and the NRC's role in regulating the nuclear industry.

Our past publications have attracted attention in the local, national and trade media. Copies of the reports have been distributed to members of the public, the nuclear industry, citizen groups, federal & state governments and members of Congress.

Greenpeace has no commercial or private interest in the agency records sought.

Since "disclosure of the information is in the public interest because it is likely to contribute significantly to the public understanding of the operation or activities of the government and is not primarily in the commercial interest of the requester" (5 U.S.C. 552 (a)(4)(A) (iii)), we request a complete waiver of any processing or duplicating costs you might incur in providing these records to us. If you rule otherwise, please notify us before filling the request.

If all or any parts of this request are denied, please cite the specific exemptions on which you rely in refusing to release the documents.

Further, since the Freedom of Information Act provides that the remainder of a file must be released if only portions are exempt from disclosure, we request that we be provided with all non-exempt portions that are reasonably segregable. Of course, we reserve our right to appeal the withholding or deletion of any information.

As provided in the Freedom of Information Act Amendments, we will expect to receive the requested records or a final determination within twenty working days. If your office is unable to fully respond to this request in that time, please send us a written estimate of when the request will be completed.
