OPPORTUNITY TO COMMENT ON DRAFT NUREG-1556, VOLUME 8, REVISION 1,
"CONSOLIDATED GUIDANCE ABOUT MATERIALS LICENSES: PROGRAM-SPECIFIC
GUIDANCE ABOUT EXEMPT DISTRIBUTION LICENSES" (STC-17-018)

Purpose: To provide Agreement States the opportunity to comment on the Office of Nuclear Material Safety and Safeguards draft NUREG-1556, Volume 8, Revision 1, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Exempt Distribution Licenses."

Background: The U.S. Nuclear Regulatory Commission (NRC) is revising the licensing guidance in the NUREG-1556 series. The NRC published NUREG-1556, Volume 8 in September 1998. The document is intended for use by applicants, licensees, and NRC staff, and is also available to the Agreement States.

Discussion: NUREG-1556, Volume 8, Revision 1, was updated by a working group comprised of NRC representatives to discuss safety culture, protection of sensitive information, and changes in regulatory policies and practices. The volume was also reviewed by a steering committee made up of NRC management, an Agreement State manager, and NRC legal staff. The notice announcing the availability of the draft volume for comment was published in the *Federal Register* (82 FR 9756) on February 8, 2017:
