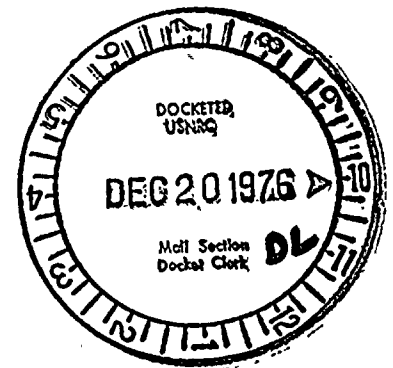

Dear Mr. Lear:

Transmitted herewith is an addendum to the report on the Reactor Containment Building (Primary Containment) Integrated Leak Rate Test completed in November 1975. The addendum replaces Sections A and D of the original report and presents the results of a detailed review performed by Niagara Mohawk Power Corporation. The review confirms the conclusion of the original report that the containment leakage meets the criteria given in Appendix J, 10 CFR 50 and the Station Technical Specifications.

Numerical differences are due in part to recalculation of test results using only the data generated during the stable last 24 hours of the 36 hour test run. Results using redundant instrumentation are retained in the report to further substantiate the overall test results.
