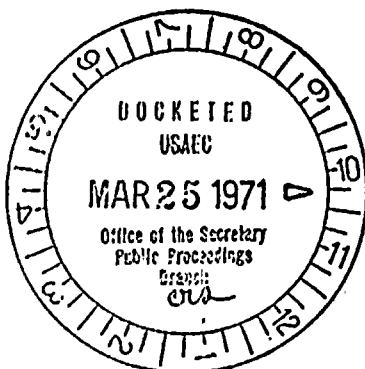

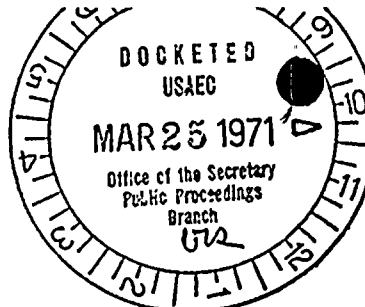
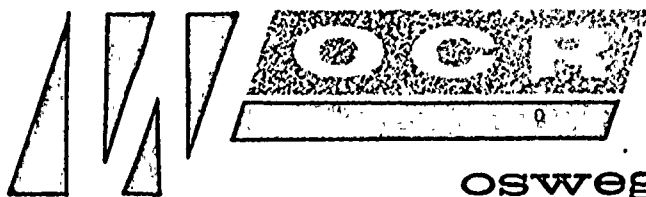

The following is an editorial of the Oswego State Broadcasting Service:

Recently, Niagara Mohawk, operators of a nuclear power plant located at Nine Mile Point just outside of Oswego, filed a petition with the Atomic Energy Commission in Washington, D.C. to raise the output of this plant from 500,000 kilowatts to 625,000 kilowatts, an increase of 25%

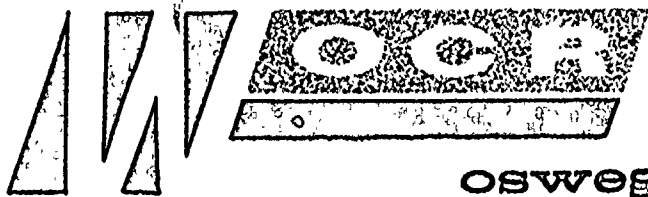
The Oswego State Broadcasting Service believes that the residents of Oswego county and the college students who live here most of the year should register their feelings on this matter with the Atomic Energy Commission Secretary in Washington, D.C.

It is a matter of public record that, even at its present output the Nine Mile Point nuclear power plant has had 34 emergency shut-downs in the past two years. It is the position of the Oswego State Broadcasting Service that until more is known about the effects of radiation on human life, and until Niagara Mohawk can show a better safety record than 17 emergency shutdowns per year...until all these things are done, Niagara Mohawk should be denied a permit to increase their power output by 25%.

Concerned citizens have until 14 April to register their feelings with the Atomic Energy Commission secretary, Washington DC. A massive letter writing campaign can prevent the increase--and your letter is the one that is needed the most. Write to this address: Atomic Energy
