Thank you for your letter of July 5, 1973, in reply to our notice dated May 23, 1973.

In order to clarify your response to Item No. 6 of our list of items of noncompliance with regulatory requirements, discussions were held between Mr. R. T. Carlson, Directorate of Regulatory Operations, and Mr. P. A. Burt, General Superintendent Nuclear Generation, on August 2, 1973. Based on these discussions, we understand that unauthorized changes to procedures will not be permitted in the future and that the development and review of procedures required by the Technical Specifications will be accomplished expeditiously to assure that approved procedures are available for maintaining and testing the facility in the future.

We will review the corrective actions taken by you regarding the other items discussed in our May 23, 1973 notice during our next inspection.
