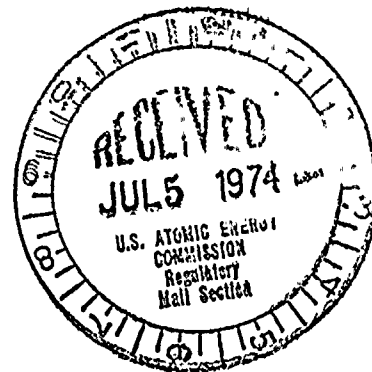

Dear Mr. Skovholt:

In our October 26, 1973 letter concerning the High Pressure Coolant Injection (HPCI) System status we committed to the performance of an off-site power test utilizing energy from other than the Normal Off-site Supply.

We are pleased to inform you that the testing has been completed, as committed, during the Spring 1974 Refueling Outage.

As was stated in the October 1973 letter, various modifications had to be made to our Bennetts Bridge Hydro Electric Station to prevent possible damage to station components and to enhance the system reliability and performance. These modifications were made prior to conducting the test.

The results of the test have been reviewed by both On-site and Off-site Review Committees. They have concluded that all pre-operational requirements for the HPCI System have been completed and that this is a closed item.

A complete report of the test and results thereof will be included in the July 1974 Semi-Annual Report.

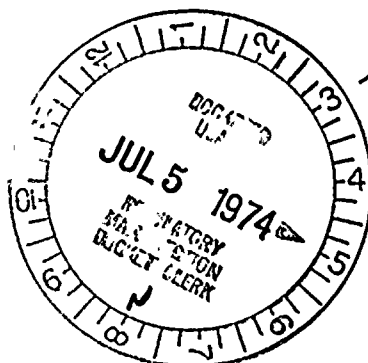
