REQUEST FOR ADDITIONAL INFORMATION FOR NINE MILE POINT UNIT 1

Provide the following cost data:

1. Capital cost of Unit 1 at time of first commercial operation in 1969.
2. Capital cost of modifications to the radwaste system at time of completion and estimated time of completion.
3. Estimated annual fuel cost, levelized over lifetime, and assumed capacity factor.
4. Estimated annual operation and maintenance cost, levelized over lifetime.
5. The levelized fixed charge rates applicable to Unit 1 and the breakdown into its components.

For your reference cost data analogous to the above was supplied for the proposed Nine Mile Point Unit 2 and can be found on pages S1-38 and S3.8-8 of the Supplements to the Environmental Report for Unit 2.
