Figure 6 shows the results of the regression analysis. The model explains 70% of the variance in the dependent variable ( $R^2 = .70$ ). The adjusted  $R^2$  value is .68. The F-value is 19.94, which is significant at the .001 level. The t-values for the independent variables are also shown. The t-value for the constant is 1.00, which is not significant.
