My letter to you, dated February 17, 1976, provided guidance with respect to information that must be filed with the Commission under the provisions of Section V.B of Appendix I to 10 CFR Part 50, issued May 5, 1975.

As discussed in our telephone conversation on March 23, 1976, the NRC staff will host a 1-day meeting at our Region I Office, 631 Park Avenue, King of Prussia, Pennsylvania, April 8, 1976, beginning at 9:00 a.m., to provide additional guidance and to discuss the submittal of data and methods of evaluation. To assure that the discussions are productive, we are requesting that you send technical representatives to this meeting who will be directly involved in furnishing the required information and data, with respect to the radwaste treatment and effluent control systems, site meteorology and hydrology and radiological dose assessment.

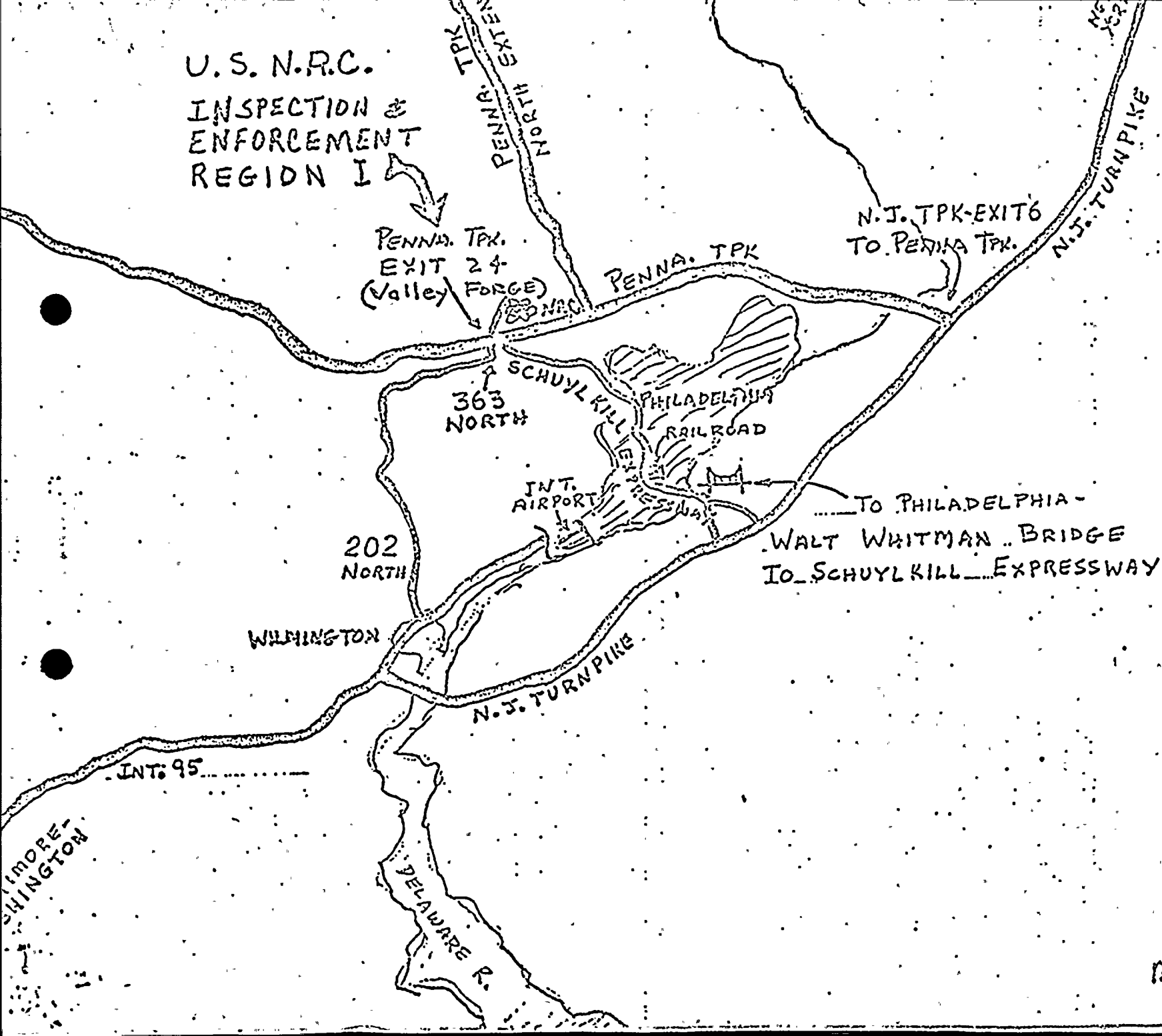

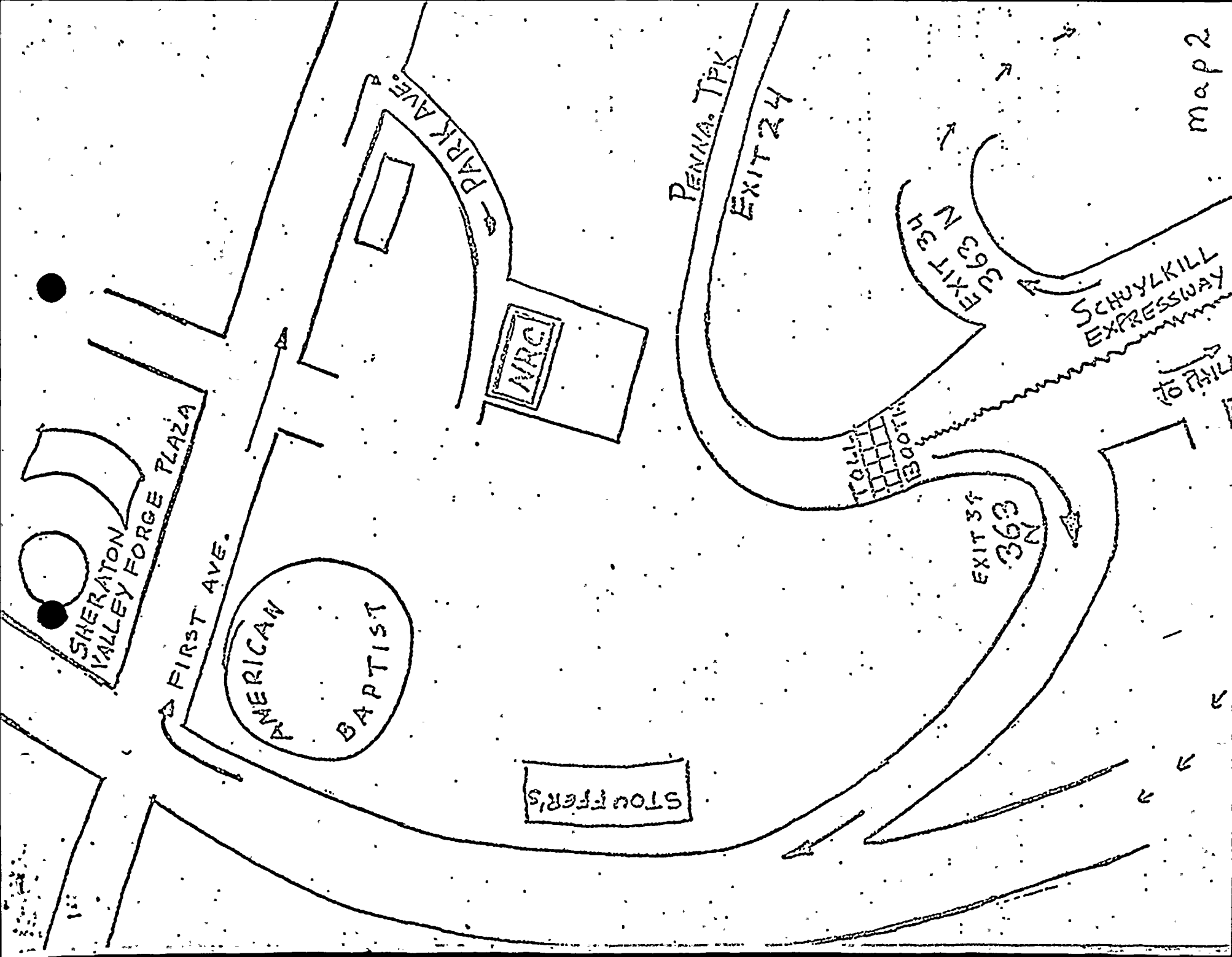
