The staff at the U.S. Nuclear Regulatory Commission (NRC) received a triennial update to the decommissioning funding plan, submitted by letter dated December 14, 2016. For the review of the submittal pertaining to special nuclear material license SNM-95, the review has been assigned Cost Activity Code LU0174. Please reference this number in any future correspondence associated with this request.

During its acceptance review, the NRC staff identified no administrative omissions or deficiencies regarding license SNM-95. As the technical review proceeds, the NRC staff may identify issues that require additional information. The NRC staff anticipates completing the subject licensing activity by the end of August 2017; this date could change depending on the findings during technical review, urgent assignments, or other factors. The NRC staff will promptly communicate any significant changes to this schedule.
