Hello Norma,

In reply to your questions:

1. *"...send me an electronic version of your cover letter, with the crosswalk of the proposed changes."*
See attached.
2. *"I noticed that there are a few changes in the application (such as drawings) that are not mentioned in the cover letter. I want to know if these changes are due to the changes related to the licensing action completed last fall for the MIDUS package."*
When we revise SARs, we indicate all new changes to the SAR text, tables, etc. with revision bars in the margins. All pages with revision bars are therefore new changes to that particular SAR revision. Drawings are a little different. Clouded changes on drawings reflect changes since the last drawing revision, and do not necessarily mean the change occurred in the particular license amendment request. You can tell which drawings were changed by noting the revision bars in the SAR drawing list in Section 1.3.2, or in our change description that we supply in the transmittal. In this case, the ***only*** changes to the drawings were the change in the DU density specifications.
3. *"I also noticed that you submitted some chapters with no change bars on it. Again, are those "page changes" related to the licensing action completed last fall?"*
We prepare and submit the SAR as a whole, not as change-pages. Therefore chapters that do not have page revision bars do not have any changed content. Note that there may be editorial differences such as "blank" pages for pagination purposes, etc.

I hope these responses answer your questions. If you have specific questions regarding certain pages or drawings, please provide me the instances and I will look into them for you. We appreciate your efforts to select the right level of review.
