This letter refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI) to determine if a former corrective action manager was discriminated against for raising safety concerns while employed at Chicago Bridge & Iron (CB&I) via Lutech Resources, Inc. (Lutech). Based on the evidence developed during the OI investigation, the NRC could not substantiate that discrimination occurred.

Please note that the complete OI investigation report, including supporting documentation, may be obtained by you and the public under the Freedom of Information Act (FOIA), subject to redaction of information pursuant to the FOIA.
