The purpose of this modification is to provide \$75,000 of incremental funding, thereby increasing the total obligation amount from \$125,000 to \$200,000. As a result of this modification action section B.1 CONSIDERATION AND OBLIGATION is hereby revised as follows:

B.1 CONSIDERATION AND OBLIGATION—FIRM FIXED PRICE (JUN 1988)

- (a) The contract type of this delivery order is Firm-Fixed Price.
- (b) The ceiling of this order for services is \$274,821.84.
- (c) The amount presently obligated with respect to this order is \$200,000.00. The obligated amount shall, at no time, exceed the order ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this order, in accordance with FAR Part 43 - Modifications. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk and may not be reimbursed by the Government.
- (d) The Contractor shall comply with the provisions of FAR 52.232-22 - Limitation of Funds, for incrementally-funded delivery orders or task orders.
- (e) FAR 52-232-18. Availability of Funds for the Next Fiscal Year (Apr 1984). Funds are not presently available for performance under this contract beyond December 31, 2017. The Government's obligation for performance of this contract beyond that date is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond December 31, 2017, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.
