DESCRIPTION OF MATERIALS OR FACILITIES

This license is amended to: 1) change the name of the licensee from EnergySolutions to EnergySolutions Services, Inc.; 2) change the name of the Other U.S. Party from Duratek Services, Inc. to EnergySolutions Services, Inc.; 3) update the licensee point of contact; and 4) extend the date of expiration from December 31, 2016, to December 31, 2021.

Class A radioactive waste consisting of hearth ash from the incineration of dry active material imported from Germany under NRC Import License IW029/01. Once processed, it will be returned to the German supplier for ultimate disposal. These materials include those which cannot be incinerated, those that were processed for volume reduction, and any waste directly attributable to processing the materials imported under IW029/01. The quantity of radioactive waste authorized for export shall not exceed that which was imported under IW029/01.

Neither this license nor any right under this license shall be assigned or otherwise transferred in violation of the provisions of the Atomic Energy Act of 1954, as amended, and the Energy Reorganization Act of 1974.

This license is subject to the right of recapture or control by Section 108 of the Atomic Energy Act of 1954, as amended, and to all of the other provisions of said Acts, now or hereafter in effect and to all valid rules and regulations of the Nuclear Regulatory Commission.
