Dear Mr. Baker:

This is in reference to your letter dated May 9, 2017, with the attached Decommissioning Funding Plan (DFP) provided in support of the requirement to update your financial assurance for License No. 20-08361-01. We completed the review of the DFP and have no additional questions about the DFP.

Please provide a new financial assurance instrument in the amount of the cost estimate for the DFP. Be sure to provide all required documents in support of the instrument. Detailed information may be found in NUREG-1757, "Consolidated NMSS Decommissioning Guidance," Volume 3, "Financial Assurance, Recordkeeping, and Timeliness," Revision 1 (NUREG-1757, Vol. 3, Rev. 1). If you provide a Statement of Intent, as in the past, the required documentation includes:

1. The statement of intent (originally signed duplicate);
2. Documentation verifying that the signatory is authorized to represent the licensee in providing the statement of intent;
3. A description of the means that will be used to adjust the site-specific cost estimate over the life of the facility;
4. A certification that financial assurance has been provided (see NUREG-1757, Vol. 3, Rev. 1, Appendix A.2.4 "Model Certification of Financial Assurance").

We will continue our review upon receipt of this information. Please reply to my attention at:


