In accordance with 10 CFR 50.90, Florida Power & Light Company (FPL) submits herewith a request to amend Facility Operating Licenses DPR-67 and NPF-16 for St. Lucie Units 1 and 2, respectively. These amendments revise Section 6.0, Administrative Controls, by deleting Figures 6.2-1 and 6.2-2 and adding to Specification 6.2 more general organizational requirements. Additional changes to Section 6.0 are submitted to reflect proposed organizational changes to the offsite organization and title changes to the composition of the Company Nuclear Review Board (CNRB).

Attachments 1 and 2 include the marked-up Technical Specification pages for St. Lucie Units 1 and 2, respectively. Attachment 3 is a description of the proposed changes, and Attachment 4 is a "Determination of No Significant Hazards Consideration."

In accordance with 10 CFR 50.91(b)(1), a copy of this proposed license amendment is being forwarded to the State Designee for the State of Florida.

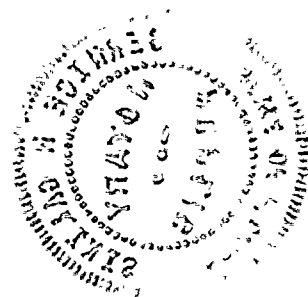
