B.2 BACKGROUND

The purpose of this action is to renew the GoTo Meeting, GoTo Webinar and GoTo Training software licenses for FY 2018. Skype is planned to be reconfigured to support external participants (both non-NRC employees and NRC employees working off site via Citrix). This will permit Skype to replace GoTo Meeting for meetings with 250 or fewer participants, Skype's participant limit. GoTo Webinar, and GoTo Training Pro will be required for training and for Webinars with more than 250 participants. OCIO management has determined that licenses for GoTo Meeting, GoTo Webinar and GoTo Training Pro should be renewed.

B.3 OBJECTIVE

The objective of this acquisition is for the U.S. Nuclear Regulatory Commission (NRC) to procure Citrix GoTo Meeting, GoTo Webinar, and GoTo Training Software Licenses for 1 year. This a software license renewal for the aforementioned Citrix software licenses. Current licenses expire on September 29, 2017.
