We have reviewed the revised draft evaluation for the Systematic Evaluation Program Topic IV-1.A, Operation with less than all loops in service, which was provided by your letter dated February 6, 1979. We have identified a typographical error in the evaluation. Your evaluation referenced a NRC Staff safety evaluation for amendment number 10 to the Technical Specifications dated March 30, 1978. The reference should have been amendment number 10 to the Provision Operating License dated March 30, 1976.
