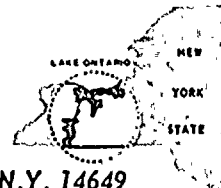

Dear Mr. Ziemann:

We have reviewed the NRC's 8/15/79 evaluation of this SEP topic for Ginna and have only minor comments.

The evaluation should point out which version of Regulatory Guide 1.14 forms the basis for the Ginna flywheel ISI program (Aug. 1975). Also, we feel that the last sentence of the evaluation would be clearer if worded as follows: "We conclude that the integrity of the flywheel for the reactor coolant pump will be adequately maintained by the Ginna inservice inspection program, which is in compliance with the recommendations of Regulatory Guide 1.14".
