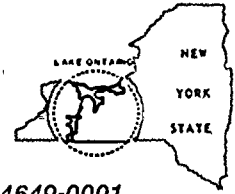


Dear Mr. Stahle:
