DEAR DR. MURLEY:

THIS LETTER IS TO CONFIRM THE OCTOBER 7, 1983 INITIATION AND
SUBSEQUENT DEACTIVATION OF THE "UNUSUAL EVENT" CLASSIFICATION
AT GINNA STATION. BELOW IS A SUMMARY OF EVENTS:

~0618 A SEISMIC EVENT OCCURRED IN THE UPSTATE AREA OF NEW
YORK. WHILE MOVEMENT WAS REPORTED IN THE ROCHESTER
AREA, THIS WAS NOT NOTED BY THE CONTROL ROOM OPERATORS.

THE CONTROL ROOM BECAME AWARE OF THE EVENT THROUGH
COMMERCIAL RADIO AND QUESTIONS BY TELEPHONE.

~0800 ACTUATION OF OUR TELEDYNE GEOTECH "STRONG-MOTION ACCEL-
EROGRAPH" MODEL RFT-250 WAS INDICATED.

0826 AN UNUSUAL EVENT WAS DECLARED AT THE SITE WITH APPROPRIATE
NOTIFICATIONS TO THE STATE OF NEW YORK, WAYNE AND
MONROE COUNTIES, AND THE NRC OPERATION OFFICE BEING
COMPLETED AT ~0911.

ACTIONS REQUIRED BY SC-5 "EARTHQUAKE EMERGENCY PLAN"
WERE INITIATED, INCLUDING STARTING OF BOTH EMERGENCY
DIESEL GENERATORS, OPERATOR TOUR/INSPECTION OF THE
PLANT, EXCLUDING CONTAINMENT, RADIATION SURVEYS IN
THE PLANT, MONITORING OF CONTAINMENT FOR INCREASED
LEAKAGE AND PROCESSING OF THE ACCELEROGRAPH FILM.

1032 INITIAL TOURS OF THE PLANT HAD INDICATED NO DAMAGE.
AFTER PORC REVIEW OF THE INCIDENT AND CONFIRMATION
OF NO DEGRADATION OF THE POWER SYSTEM GRID RELIABILITY,
THE EMERGENCY DIESEL GENERATORS WERE REMOVED FROM
SERVICE.

THE PORC COMPLETED REVIEW OF ALL PLANT INSPECTIONS WHICH INDICATED NO ABNORMALITIES, AND REVIEWED THE RESULTS OF THE ACCELEROGRAPH. THE RESULTS INDICATED THAT ACTUATION OF THE ACCELEROGRAPH HAD NOT OCCURRED, RATHER IT IS BELIEVED THAT THE ACTUATION INDICATING CIRCUIT WAS NOT RESET AFTER THE LAST CALIBRATION. THE UNITS WERE CONFIRMED TO BE FUNCTIONAL BY CALIBRATION INDICATIONS AND WOULD HAVE RECORDED AN EVENT IN EXCESS OF 0.01g. PORC RECOMMENDED REDUCTION OF THE CLASSIFICATION IN ACCORDANCE WITH SC-110 "GINNA STATION EVENT EVALUATION FOR REDUCING THE CLASSIFICATION". UPON CONCURRENCE FROM THE VICE PRESIDENT OF ELECTRIC AND STEAM PRODUCTION, THE UNUSUAL EVENT WAS TERMINATED AT 1340 HOURS.
