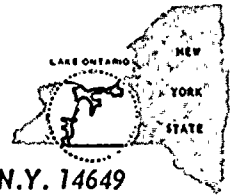

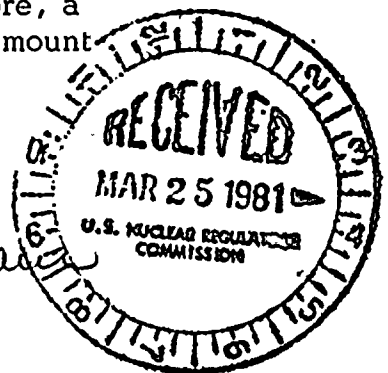
Dear Ms. Diggs:

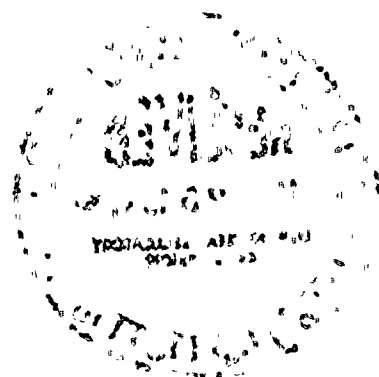
