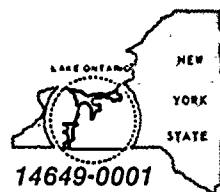

Enclosed is an Application for Amendment to Operating License to amend Appendix A of that license to eliminate the steam flow/feed flow reactor trip. The enclosed Amendment will become effective after NRC approval and PORC acceptance for operation of the new Digital Feedwater Control System, which RG&E plans to install during the 1991 refueling outage.

Also enclosed is a Westinghouse authorization letter, CAW-90-074, accompanying affidavit, Proprietary Information Notice, and Copyright Notice.

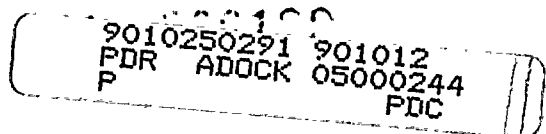
