Enclosed is an Application for Amendment to Operating License No. DPR-18 to amend Appendix A of that license to revise Ginna Technical Specifications 6.9.1.2 and 6.9.2.5. By reference (a) the Nuclear Regulatory Commission (NRC) amended 10CFR50.4 which establishes procedures for submitting correspondence, reports, applications, or other written communications and specify the number of copies required by the NRC. 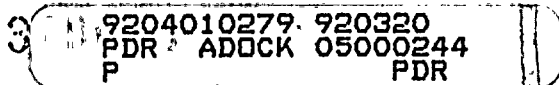
