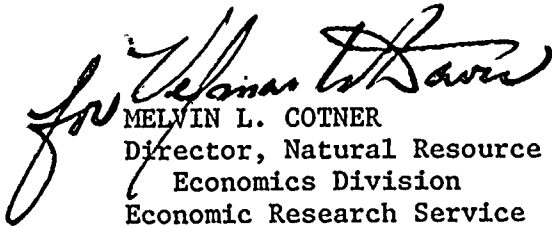

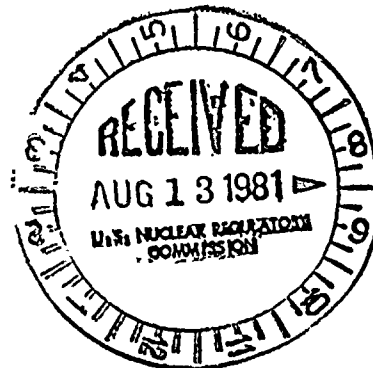
Dear Mr. Schwencer:
