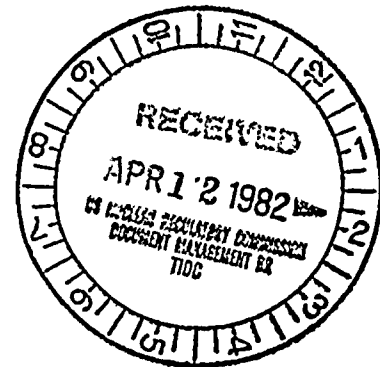

Subject: NUCLEAR PROJECT NO. 2
VACUUM BREAKER CYCLING

In response to a request by F. Eltawila of the Containment System Branch, we anticipate reaching a decision point on resolution of the vacuum breaker cycling issue, by July 15, 1982. This decision must await the outcome of ongoing generic programs to quantify loading conditions and establish the structural capacity of the vacuum breakers for Mark II plants, as well as other WNP-2 plant unique investigations currently underway.
