SHIFT SUPPORT SUPERVISOR TRAINING

The purpose of this letter is to confirm information provided by a telephone conversation on March 22, 1982 with your Mr. John Allenspach and our Messrs. R.M. Nelson and R.D. Davidson.

The Shift Support Supervisor will receive systems training up to and including systems and procedures training prior to fuel load. This systems training, combined with preoperational test experience, will provide the Shift Support Supervisor with the requisite systems knowledge. The length of the Systems and Procedures class may vary; however, the content of the training will remain essentially intact.

Following fuel load, materials covered in the present Systems and Procedures class will be included in the WNP-2 simulator training, consisting of classroom systems training and on-the-job training.
