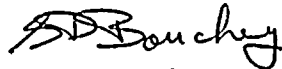

The dynamic loads which these valves are subjected to during a seismic or a LOCA situation will be finalized with a subsequent submittal in March 1983. The stress analyses of these valves will be completed prior to fuel load. The enclosed information and our commitment for completion of the required analyses will close-out Outstanding Issue No. 26.
