Reference: Letter, G02-83-1056, G. C. Sorensen (SS) to A.  
Schwencer (NRC), "Listing of Preoperational and  
Acceptance Tests that may be Completed Post Fuel  
Load (Amended)", dated November 15, 1983

The reference letter stated that portions of the Chemical Waste System, namely the Waste Concentrators, which are not necessary to support plant operation would not be tested prior to fuel load and that testing would occur later using PT 33.0-B. Due to the Supply System contract with Chem Nuclear Systems, Inc. to process wet, solid radwaste, the preoperational test for the Waste Concentrators, PT 33.0-B, will be suspended indefinitely. This does not constitute a major change to the overall radwaste treatment system as defined in the Technical Specifications. It is requested that the preoperational test PT 33.0-B be removed from the list of preoperational/acceptance tests in Attachment 1 to the WNP-2 Operating License NPF-21.
