The 24-hour, 100 percent humidity test has been successfully completed. The equipment performed satisfactorily.

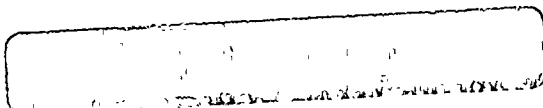
