In accordance with 10CFR50.71, the Supply System hereby submits sixty (60) copies of Amendment 34 to the WNP-2 (license basis) FSAR. This revision reflects changes made since the last submittal of the FSAR and is current as of January 1984. This amendment is intended to do the following:

1. Clarify ambiguities, make editorial corrections and eliminate typographical errors and inconsistencies in the text.
2. Update technical and equipment qualifications to satisfy commitments to the NRC staff and provide minor clarifications in the text.
3. Provide further elaborations of systems to reflect present conditions.
4. Include test progress by incorporating preoperational test results, failure analyses, and safe shutdown analyses previously reported; additionally satisfy commitments to provide final break locations and stress summary analyses for Section 3.6, and
5. Report start-up test progress and results via incorporation of necessary Technical Specification values, responses to appropriate Regulatory Guides, and responses to recent questions from the NRC staff.
