On December 13, 1984, the Power Ascension Test Program (PATP) at WNP-2 was completed. As a result of the successful completion of the PATP, including the 100 hour warranty run, Managing Director Don Mazur declared that the plant was "... ready to be operated on a commercial basis..."

Upon completion of the PATP, the primary containment atmosphere has been inerted in accordance with the plant technical specifications.

A copy of the reference letter, establishing December 13, 1984 as the "Official Date of Commercial Operation" is attached for your information.




Subject: COMMERCIAL OPERATION DATE EFFECTIVE DECEMBER 13, 1984

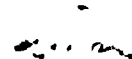
