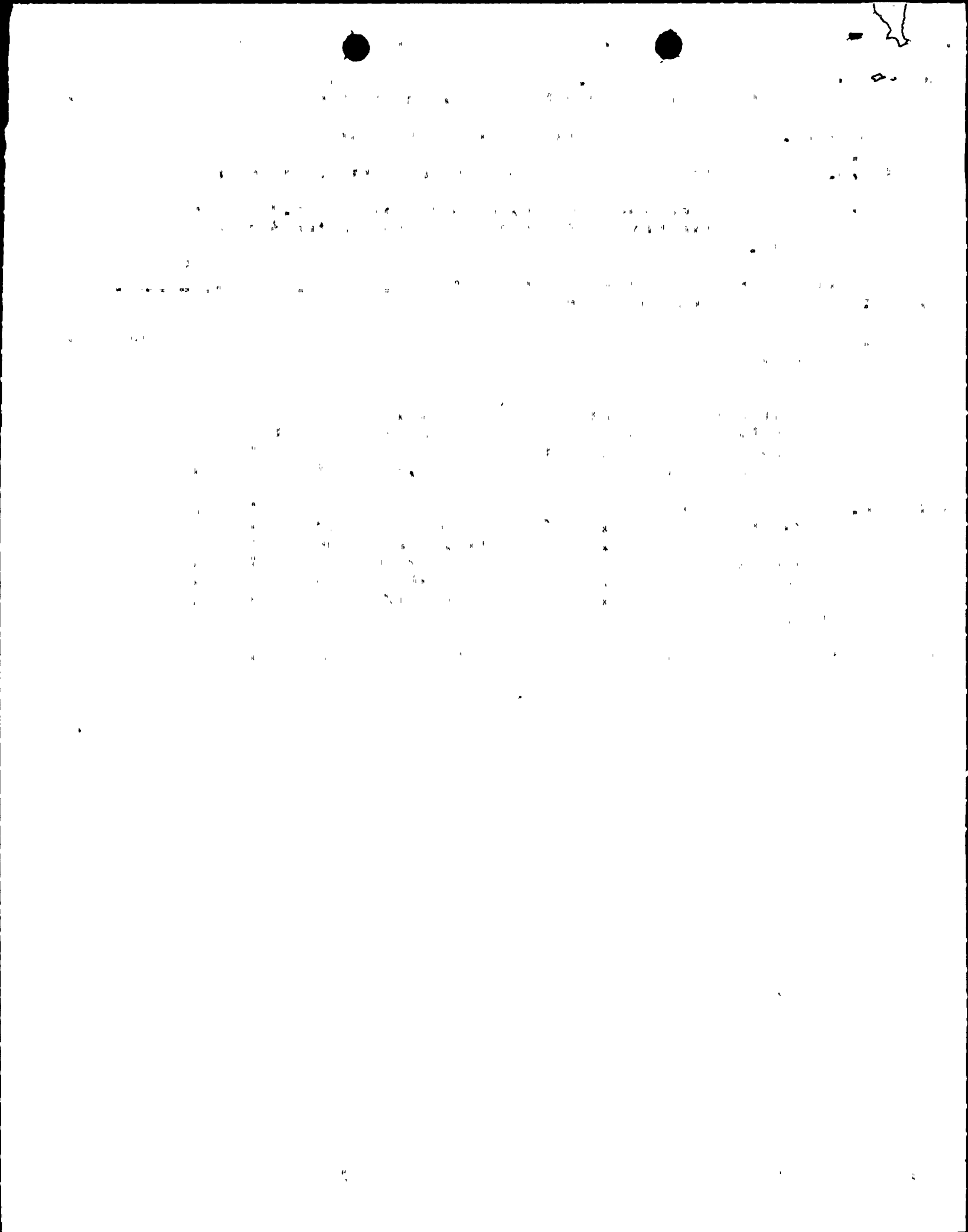

The amount of the released H_2O was measured by the weight difference of the hydrogel before and after the swelling in the H_2O_2 solution. The concentration of the H_2O_2 solution was 0, 0.01, 0.05, 0.1, 0.5, 1, 5, and 10% (v/v). The amount of the released H_2O was measured at 37°C for 24 h.
