NPF-21, WPPSS NUCLEAR PROJECT NO. 2

During their regular meeting of June 24 1985, the Washington State Energy Facility Site Evaluation Council reviewed and subsequently adopted a motion indicating their concurrence with the Washington Public Power Supply System's request, by letter dated June 18, 1985, for an emergency change to the Operating License for Nuclear Project No. 2. Specifically, the Supply System's request involves an emergency change to Technical Specification 3.8.4.2, Primary Containment Penetration Conductor Overcurrent Protective Devices.
