Same Subject, dated May 13, 1986

The reference letter requested the status of generic issue solutions applicable to WNP-2 and requested an attached table be completed showing the present WNP-2 status. In a phone conversation between Messrs. J. O. Bradfute of your staff and P. L. Powell (SS), it was indicated that those items on the list having a "C" under the column "Lic Act Complete" have a known status and need no further reporting. Additionally, Item A-20, 10CFR 50.62, Operating Reactor Reviews, has not been scheduled by the Staff and therefore has no corresponding status at WNP-2. Therefore, the remaining issues to be addressed are, by MPA number, B-77, B-86, B-93, F-09 and F-71. No other omitted significant issues have been recognized by the Supply System that need be added to the list.

The attached provides the status for those remaining issues identified above. Should you have any further questions, please contact Mr. P. L. Powell, Manager, WNP-2 Licensing.

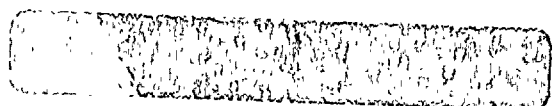
