Reference 1) requested a change to the WNP-2 Technical Specifications to reflect modifications to the Traversing Incore Probe (TIP) purge line currently scheduled for completion during the forthcoming Spring 1987 refueling outage. Reference 2) provided supplemental information with regard to the requested change. The purpose of this letter is to provide clarification to the Reference 2) information with regard to testing of the TIP purge line configuration. The standard testing done and required for all containment penetrations and associated valves will be accomplished. That is type B testing will be scheduled for the penetration and Type C testing with air for TIP V-6 and V-15.
