

SUBJECT: SUMMARY OF SEPTEMBER 29, 2017, PUBLIC MEETING WITH
NUCLEAR ENERGY INSTITUTE REGARDING APPENDIX X TO
NEI 05-04, NEI 07-12, AND NEI 12-13, FINDING AND
OBSERVATION CLOSURE PROCESS

On September 29, 2017, the U.S. Nuclear Regulatory Commission (NRC) staff held a public meeting¹ with staff from the Nuclear Energy Institute (NEI). The purpose of the meeting was to discuss the finding and observation (F&O) closure process described in Appendix X to NEI 05-04, NEI 07-12, and NEI 12-13. Specifically, the meeting was to provide the NRC staff's feedback from previous observations of licensee implementation of the F&O closure process.

During the meeting, the NRC staff presented slides that provided feedback from NRC staff observations of licensees implementing the F&O closure process.² Additionally, the NEI staff gave a presentation of their feedback on the NRC's observation of the closure process.³ No objections were expressed to the feedback provided by either party.

No regulatory decisions were made and both the NRC and NEI staffs indicated that they would consider the items discussed in the meeting.

Following the discussion, an opportunity was afforded to any other participants who wished to ask questions or make comments. No questions or comments were received in the meeting. Following the meeting, a voicemail was received from a member of the public who was in attendance, who indicated that they felt the process was not rigorous.
