Subject: AMENDMENT TO FACILITY OPERATING LICENSE NPF-21,  
WPPSS NUCLEAR PROJECT NO. 2

During its regular meeting of February 8, 1988, the Washington State Energy Facility Site Evaluation Council reviewed and adopted a motion indicating that the Council has no comments on the Washington Public Power Supply System's request by letter dated February 9, 1987, to amend the Operating License for Nuclear Project No. 2.

The Supply System's request involves an amendment to Technical Specification 4.1.3.5 - Control Rod Scram Accumulators - to revise the control rod hydraulic control unit accumulator nitrogen low pressure alarm to provide adequate instrument drift allowance.

The Council was notified of the proposed amendment request by the Supply System in accordance with the notification requirements of 10 CFR 50.91.
