In the reference, the Supply System provided additional information following our response to NRC Inspection Report 97-13. We stated in the reference that lessons learned from the apparent violation (failure to perform adequate safety evaluation in accordance with 10 CFR 50.59) would be provided as feedback training to safety evaluation preparers and reviewers, as well as Plant Operations Committee and the Corporate Nuclear Safety Review Board (CNSRB). We indicated that this action was expected to be completed by April 30, 1998.

The training material was provided to the targeted individuals in early April. Each individual was asked to acknowledge that they had read and understood the training material. This letter is to inform you that this action was actually completed on May 11, 1998 when the final acknowledgment from an off-site member of our CNSRB was received.
