- In the reference letters the Supply System provided status reports on the scheduled completion dates for eight (8) tasks that had been identified as improvement initiatives in the WNP-2 Fire Protection Program Reevaluation Report. As discussed in Reference 2, six (6) of those tasks had been completed, and the remainder were on schedule. The purpose of this letter is to provide a current status report on the remaining two (2) tasks, numbers 6 and 8.

Task No. 6 - Document in a report justification for deviations from NFPA codes.  
This task was scheduled for completion 9/87.

Status - The report itself was completed 11/87. In the last status report there was only one new procedure remaining to be implemented to complete this task entirely. That procedure (PPM 2.8.13, Fire Suppression System Inspection) was put in place September 7, 1988.

This task is now complete.

STATUS REPORT UPDATE

Task No. 8 - Complete update of the FSAR to clarify requirements basis (part of the routine 1988 FSAR update). This task was scheduled for completion 9/88.

Status - The changes necessary to comply with 10CFR50.71, along with some minor clarifications, were included with Amendment 39 as scheduled. This amendment was submitted to the NRC on August 26, 1988 (letter G02-88-184).

The remaining changes will be submitted following NRC approval of Amendment 37.

In conclusion, with the exception of the remaining actions necessary to complete Task No. 8 subsequent to NRC approval of Amendment 37, the improvement initiatives identified in the WNP-2 Fire Protection Program Reevaluation Report have been satisfactorily completed.
