Dear Mr. Varga:

Pursuant to 10 CFR 2.101 and 50.34(b), the Washington Public Power Supply System herewith tenders its Final Safety Analysis Report for WPPSS Nuclear Project No. 2 (WNP-2).

In accordance with the requirements of 10 CFR 50.30(c)(3), fifteen (15) copies of the Safety Analysis Report and ten (10) copies of the general information are attached for your completeness review. Additional copies will be submitted as required upon notification of docketing.

We have also attached an application and accompanying affidavit, as required by 10 CFR 2.790, requesting that certain confidential commercial information which is treated as "proprietary" by ourselves and our nuclear steam system supplier (The General Electric Company) be withheld from public disclosure. Four (4) copies of the proprietary material are attached for your use.

The security plan for WNP-2 (FSAR Section 13.6) is being prepared to meet the NRC "Requirements for Physical Protection of Nuclear Power Reactors" and will be submitted as an FSAR amendment in December 1978. Technical Specifications (Chapter 16) will also be provided in an amendment. Since these two items represent a minor percentage of the total FSAR and are somewhat independent of the technical description of the plant, it is requested that your review proceed without this material.

The FSAR as submitted has been prepared in accordance with Revision 2 of the "Standard Format and Content of Safety Analysis Reports for Nuclear Power Plants." Responses to NRC staff requests for additional information which comprised enclosure 1 to your letter of June 24, 1977, have been incorporated in the FSAR.

As we discussed in our meeting of August 31, 1977 with you and members of the staff, we are concerned over the fact that the FSAR was previously submitted for acceptance review on March 18, 1977, and a response from the staff was not prepared until June 24, 1977. We trust that every effort will be expended by the staff to assure that this submittal receives timely review. In that regard, we request that a meeting between our respective staffs be scheduled for the week of April 24, 1978, to discuss the results of your acceptance review and future scheduling of activities relating to the WNP-2 docket. Details of this meeting will be coordinated with the NRC Licensing Project Manager, Mr. Lynch.
