demonstrating operability by March 31, 1982.

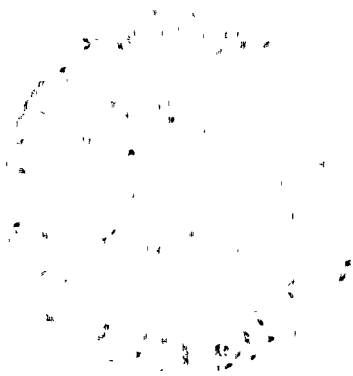
Any PVNGS containment purge valves that do not satisfy the operability criteria
